

Regulations of the promotion "Global domains at netart.com"

I. Introductory provisions

- 1. **Promotion Purpose:** To familiarise the Client with the domain registration service provided by netart.com sp. z o.o. with its registered office in Cracow, Pana Tadeusza 2, 30-727 Cracow, entered into the business register of the National Court Register kept by the District Court XI Commercial Division in Cracow under KRS number: 0001000590, NIP: 6793252454, share capital: PLN 1 000 000,00 (in words: one million zloty) hereinafter referred to as netart.com.
- Duties (obligations) of the parties: netart.com undertakes to provide services according to the terms set out in these Regulations, and the Client undertakes to use the service according to these Regulations, the GTC, the Regulations of SSL Certificates, and other provisions referred to in the said documents.

II. Organiser of the Promotion

1. The organiser of the promotional action "Global domains at netart.com" is netart.com.

III. Legal regulation of the promotion

- 1. The legal basis for the promotion is provided by these Regulations, which is also the only document setting out the detailed rules of the promotion. The content of the Regulations is available at https://www.netart.com.
- 2. Participation in the promotion is voluntary.
- 3. The interpretation of the Regulations rests solely with the organiser of the promotional campaign. This provision shall not apply to a Consumer residing in the territory of the European Union.
- 4. The promotion participant may be any Client of netart.com having an account in the Client Panel, who, during the period of the promotion, orders the service of registering the domains referred to in section V.5 and fulfills the conditions specified in these Regulations, in particular in section V.1. of these Regulations (hereinafter referred to as the "Participant" or "Promotion Participant").

IV. Duration of the promotion

- 1. The promotion applies to the domains listed in Section V.5 ordered during the period from 05.10.2023 until further notice.
- 2. The date determining participation in the promotion is the date of ordering the domain referred to in section IV.1. above via https://www.netart.com.

V. Promotion rules

- 1. Participation in this promotion is conditional upon the Promotion Participant's enabled consent or granting of consent to provide commercial information at the time of placing an order during this promotion and according to the content of the clause found in particular at https://www.netart.com, in the Client Panel or when placing an order for a service during this promotion.
- The amount of discount granted to the Participant under this promotion and upon fulfillment of the conditions for participation in the promotion is the difference between the standard net price specified in the price list available at https://www.netart.com and the promotional price specified in these Regulations.
- 3. The discount is granted to the Promotion Participants for giving their consent to the transmission of commercial information, according to section V.1. above. The Promotion Participant has the right to withdraw the consent to the sending of commercial information by netart.com. The discount will be granted for the duration of the Promotion Participant's consent to the transmission of commercial information, as specified in the clause referred to in section V.1. of these Regulations, in proportion to the duration of this period, up to the maximum duration of the promotional Subscription Period.
- 4. Withdrawal or non-granting by the Client of the consent to send commercial information by netart.com during the promotional Subscription Period of the service may result in the loss of the Client's right to the discount and the obligation on the part of that Client to pay the standard price specified in the price list available at https://www.netart.com, from the day following the day on which the consent to send commercial information was withdrawn (or from the day following the day on which netart.com obtained information about the non-granting of the consent).
- 5. The promotion applies to domains ordered by the Client via https://www.netart.com during the promotion period, whereby as part of the promotion the Client is entitled to order:
 - a) .com domain for the first Subscription Period of one year, at a promotional price of 20.00 BGN net,
 - b) .net domain for the first Subscription Period of one year, at a promotional price of 20.00 BGN net,
 - c) .org domain for the first Subscription Period of one year, at a promotional price of 20.00 BGN net,
 - d) .biz domain for the first Subscription Period of one year, at a promotional price of 30.00 BGN net,
 - e) .info domain for the first Subscription Period of one year, at a promotional price of 35.00 BGN net.

- 6. In addition, the Client is entitled to order domains specified in section V.5, for a Subscription Period longer than that specified in section V.5, provided that such service is available. The order price is the result of adding together the promotional price for the first Subscription Period and the standard price for each additional Subscription Period, as specified in the price list available at https://www.netart.com.
- 7. The number of services described in V.5 and V.6 is unlimited. When ordering a service, the Client is obliged to pay the total price in advance for all Subscription Periods.
- 8. In the case of each transfer of a domain, registered in the promotion described in section V.5., to another service provider before the expiration of the period for which the service was ordered in the promotion, the Client will be obliged to pay to netart.com a contractual penalty in the amount corresponding to the standard price (specified in the price list available at https://www.netart.com), for the period from the day following the day of transferring the domain to another service provider to the day on which the last Subscription Period of the service ordered in the promotion would have ended.
- 9. The transfer of a domain registered under this promotion to another Customer Panel is possible as long as the Customer to whom the domain is transferred can take advantage of this promotion.
- 10. The net prices specified above will be increased by the applicable VAT, at the rate in force in the country where the service is taxed in accordance with the applicable legislation.
- 11. The selection of the domain in the promotion is made during the order process.
- 12. The renewal of the Subscription Period of the service ordered in the promotion is made under the terms and conditions in effect at the time of renewal.
- 13. The use of the service ordered during the promotion period is subject to the general rules for the use of services, contained in the General Terms and Conditions and the Regulations of the domain registration service and related services.

VI. Other provisions

- 1. The relationship between netart.com and the Client or the Registrant is governed exclusively by the provisions of the substantive law of the Republic of Poland. The above provision shall not limit the rights acquired under the law by a Consumer residing in the territory of the European Union.
- Any disputes that may arise from the agreement between the Client or the Registrant and netart.com, which cannot be resolved using the complaint procedure, will be settled by a common court of law with jurisdiction over the seat of netart.com. The place of provision of the service is the registered office of netart.com.
- 3. The language applicable to the conduct and settlement of disputes referred to in Section VI.2 above and settled by Polish courts, shall be Polish.
- 4. For matters not regulated in these Regulations, the provisions of the General Terms and Conditions available at https://www.netart.com shall apply.
- 5. Regulations as of 05.10.2023.
