

Regulations of the promotion "Country-specific domains at netart.com"

I. Introductory provisions

- Promotion Purpose: To familiarise the Client with the domain registration service provided by netart.com sp. z o.o. with its registered office in Cracow, Pana Tadeusza 2, 30-727 Cracow, entered into the business register of the National Court Register kept by the District Court XI Commercial Division in Cracow under KRS number: 0001000590, NIP: 6793252454, share capital: PLN 1 000 000,00 (in words: one million zloty) - hereinafter referred to as netart.com.
- Duties (obligations) of the parties: netart.com undertakes to provide services according to the terms
 set out in these Regulations, and the Client undertakes to use the service according to these
 Regulations, the GTC, the Regulations of SSL Certificates, and other provisions referred to in the said
 documents.

II. Organiser of the Promotion

1. The organiser of the promotional action "Country-specific domains at netart.com" is netart.com.

III. Legal regulation of the promotion

- 9. The number of services available under the promotion described in Section V.8. is unlimited. When ordering a service, the Customer is obliged to pay the entire price in advance, for all Subscription Periods.
- 10. In the case of each transfer of a domain registered under the promotion described in point V.5. or V.8 to another service provider, before the expiry of the period for which the service was ordered under the promotion, the Customer will be obliged to pay netart.com a contractual penalty in the amount corresponding to the standard price (indicated in the price list available at https://www.netart.com), for the period from the day following the date of transfer of the domain to another service provider until the date on which the last Subscription Period of the service ordered under the promotion would have ended.
- 11. Transferring a domain registered under this promotion to another Customer Panel is possible provided that the Customer to whom the domain is transferred can take advantage of this promotion.
- 12. Due VAT will be added to the net prices indicated above, at the rate applicable in the country where the service is taxed in accordance with applicable law.
- 13. The domain in the promotion is selected during the ordering process.
- 14. The extension of the Subscription Period of the service ordered in the promotion takes place on the terms and conditions applicable at the time of renewal of the service.
- 15. The use of the service ordered during the promotion period is subject to the general rules for the use of services contained in the General Terms and Conditions of Contracts and the Regulations for the provision of domain registration and related services.

VI. Other provisions





- 1. The relationship between netart.com and the Client or the Registrant is governed exclusively by the provisions of the substantive law of the Republic of Poland. The above provision shall not limit the rights acquired under the law by a Consumer residing in the territory of the European Union.
- Any disputes that may arise from the agreement between the Client or the Registrant and netart.com, which cannot be resolved using the complaint procedure, will be settled by a common court of law with jurisdiction over the seat of netart.com. The place of provision of the service is the registered office of netart.com.
- 3. The language applicable to the conduct and settlement of disputes referred to in Section VI.2 above and settled by Polish courts, shall be Polish.
- 4. For matters not regulated in these Regulations, the provisions of the General Terms and Conditions available at https://www.netart.com shall apply.
- 5. Regulations as of 17.07.2024.
