

Regulations of the promotion "DNS Anycast service at netart.com"

I. Preliminary Provisions

- 1. Promotional purpose: Familiarizing the Customer with the DNS Anycast Service provided by netart.com Sp. z o.o. with its registered office in Krakow, ul. Pana Tadeusza 2, 30-727 Krakow, registered in the Register of Entrepreneurs kept by the District Court for Krakow Śródmieście in Krakow, XI Commercial Division of the National Court Register under KRS no.: 0001000590, with a share capital of PLN 1,000,000.00 (in words: one million zloty), REGON no.: 523601938, NIP no.: 6793252454, email address: contact@netart.com hereinafter referred to as netart.com.
- Duties (obligations) of the parties: netart.com undertakes to provide services according to the terms set
 out in these Regulations, and the Client undertakes to use the service according to these Regulations, the
 GTC, the Regulations of the DNS Anycast Service, and other provisions referred to in the said documents.

II. Organiser of the Promotion

1. The organizer of the promotional action "DNS Anycast Service at netart.com" is netart.com.

III. Legal regulation of the promotion

- 1. The legal basis for the promotion is provided by these Regulations, which is also the only document setting out the detailed rules of the promotion. The content of the Regulations is available at https://www.netart.com.
- 2. Participation in the promotion is voluntary.
- 3. The interpretation of the Regulations rests solely with the organiser of the promotional campaign. This provision shall not apply to a Consumer residing in the territory of the European Union.
- 4. The promotion participant may be any Client of netart.com having an account in the Client Panel, who, during the period of the promotion, orders the DNS Anycast service referred to in section V.3. and fulfils the conditions specified in these Regulations (hereinafter referred to as the "Participant" or "Promotion Participant").

IV. Duration of the promotion

- 1. The promotion applies to services ordered from 17.04.2025 until further notice.
- 2. The date determining participation in the promotion is the date of ordering the DNS Anycast service via https://www.netart.com.

V. Promotion rules

- 1. The amount of discount granted to the Participant under this promotion and upon fulfilment of the conditions for participation in the promotion is the difference between the standard net price specified in the price list available at https://www.netart.com and the promotional price specified in these Regulations.
- 2. The discount is granted to Participants for the duration of the promotional Subscription Period at most.
- 3. The promotion applies to the DNS Anycast service ordered by the Client via https://www.netart.com during the promotion period, whereby under the promotion the Client is entitled to order the DNS Anycast service during the first Subscription Period lasting 1 year at a promotional price of 0 GBP, for each type of domain.
- 4. The Client may not use the promotion described in section V.3. when ordering the DNS Anycast service for a domain for which the DNS Anycast service has already been ordered or provided within the previous 12 months, and for a domain for which netart.com was the registrar within the previous 12 months before ordering the DNS Anycast service. The number of services available in the promotion described in section V.3. above is unlimited.
- 5. The selection of the service in the promotion is made during the order process.
- The renewal of the Subscription Period of the service ordered in the promotion is made under the terms and conditions in effect at the time of renewal.
- 7. The use of the service ordered during the promotion period is subject to the general rules for the use of services, contained in the General Terms and Conditions and the Regulations of the DNS Anycast service.

VI. Other provisions

- 1. The relationship between netart.com and the Client is governed exclusively by the provisions of the substantive law of the Republic of Poland. The above provision shall not limit the rights acquired under the law by a Consumer residing in the territory of the European Union.
- 2. Any disputes that may arise from the agreement between the Client and netart.com, which cannot be resolved using the complaint procedure, will be settled by a common court of law with jurisdiction over the seat of netart.com. The place of provision of the service is the registered office of netart.com.
- 3. The language applicable to the conduct and settlement of disputes referred to in Section VI.2. above and settled by Polish courts, shall be Polish.
- 4. For matters not regulated in these Regulations, the provisions of the General Terms and Conditions available at https://www.netart.com shall apply.
