

#### Regulations of the promotion "Super VPS server in netart.com"

## I. Introductory provisions

- Promotion Purpose: To familiarise the Client with the VPS service provided by netart.com sp. z o.o. with
  its registered office in Cracow, Pana Tadeusza 2, 30-727 Cracow, entered into the business register of the
  National Court Register kept by the District Court XI Commercial Division in Cracow under KRS number:
  0001000590, NIP: 6793252454, share capital: PLN 1 000 000,00 (in words: one million zloty) hereinafter
  referred to as netart.com.
- 2. **Duties (obligations) of the parties:** netart.com undertakes to provide services according to the terms set out in these Regulations, and the Client undertakes to use the service according to these Regulations, the GTC, the Regulations of the VPS Service, and other provisions referred to in the said documents.

#### II. Organiser of the Promotion

1. The organiser of the promotional action "Super VPS server in netart.com" is netart.com.

## III. Legal regulation of the promotion

- 1. The legal basis for the promotion is provided by these Regulations, which is also the only document setting out the detailed rules of the promotion. The content of the Regulations is available at https://www.netart.com.
- 2. Participation in the promotion is voluntary.

  - c) Cloud VPS Pro in the Subscription Period of one year at a promotional price of 600.00 GBP net (the lowest price for this offer from the period of 30 days prior to the application of the price reduction -600.00 GBP net),
  - d) Cloud VPS Max in the Subscription Period of one year at a promotional price of 1 200.00 GBP net (the lowest price for this offer from the period of 30 days prior to the application of the price reduction – 1 200.00 GBP net),

- h) Cloud VPS Speed Pro in the Subscription Period of one year at a promotional price of 1 200.00 GBP net (the lowest price for this offer from the period of 30 days prior to the application of the price reduction – 1 200.00 GBP net),

- 11. The prices specified above should be increased by the applicable VAT, at the rate in force in the country where the service is taxed in accordance with the applicable legislation.
- 12. When ordering a service referred to in sections V.5., V.6., V.7., V.8., V.9., V.10. the Client is obliged to pay the full price in advance, for the full Subscription Period.
- 13. The selection of the service in the promotion is made during the order process. The number of services available in the promotion described in sections V.5., V.6., V.7., V.8., V.9., V.10. is unlimited.
- 14. The renewal of the Subscription Period of the service ordered in the promotion is made under the terms and conditions in effect at the time of renewal.
- 15. The use of the service ordered during the promotion period is subject to the general rules for the use of services, contained in the General Terms and Conditions and the Regulations of the VPS Service.

# VI. Other provisions

- 1. The relationship between netart.com and the Client is governed exclusively by the provisions of the substantive law of the Republic of Poland. The above provision shall not limit the rights acquired under the law by a Consumer residing in the territory of the European Union.
- 2. Any disputes that may arise from the agreement between the Client and netart.com, which cannot be resolved using the complaint procedure, will be settled by a common court of law with jurisdiction over the seat of netart.com. The place of provision of the service is the registered office of netart.com.
- 3. The language applicable to the conduct and settlement of disputes referred to in Section VI.2 above and settled by Polish courts, shall be Polish.
- 4. For matters not regulated in these Regulations, the provisions of the General Terms and Conditions available at https://www.netart.com.shall.apply.
