

## Regulations of the promotion "Fast hosting at netart.com"

### I. Introductory provisions

1. **Promotion Purpose:** To familiarise the Client with the Hosting Service and the Additional Service provided by netart.com sp. z o.o. with its registered office in Cracow, Pana Tadeusza 2, 30-727 Cracow, entered into the business register of the National Court Register kept by the District Court XI Commercial Division in Cracow under KRS number: 0001000590, NIP: 6793252454, share capital: PLN 1 000 000,00 (in words: one million zloty) - hereinafter referred to as netart.com.
2. **Duties (obligations) of the parties:** netart.com undertakes to provide services according to the terms set out in these Regulations, and the Client undertakes to use the service according to these Regulations, the GTC, the Regulations of the Hosting Service and Additional Service, and other provisions referred to in the said documents.

### II. Organiser of the Promotion

1. The organiser of the promotional action "Fast hosting at netart.com" is netart.com.

### III. Legal regulation of the promotion

1. The legal basis for the promotion is provided by these Regulations, which is also the only document setting out the detailed rules of the promotion. The content of the Regulations is available at <https://www.netart.com>.
2. Participation in the promotion is voluntary.
3. The interpretation of the Regulations rests solely with the organiser of the promotional campaign. This provision shall not apply to a Consumer residing in the territory of the European Union.
4. - 12. The net prices specified above will be increased by the applicable VAT, at the rate in force in the country where the service is taxed in accordance with the applicable legislation.
- 13. When ordering a service referred to in sections V.5., V.6., V.7., V.8., V.9., V.10., V.11. the Client is obliged to pay the full price in advance, for the full Subscription Period, subject to the provisions of section V.14.
- 14. If an Additional Service referred to in sections V.8., V.9., V.10., V.11. is ordered during the Subscription Period that begins during the Subscription Period of the Hosting Service, the Additional Service is billed at a promotional price, which is calculated proportionally to the number of days remaining in the Subscription Period of the Hosting Service for which the Additional Service was ordered. For the calculation, the promotional price applicable to the Additional Service with the duration of the Subscription Period of the Hosting Service for which the Additional Service was ordered will be used. The number of days remaining until the end of the Subscription Period of the Hosting Service will also include the day of ordering the Additional Service. The Client is obliged to pay the full price in advance for all days remaining until the end of the Subscription Period.
- 15. The selection of the service in the promotion is made during the order process. The number of services available in the promotion described in sections V.5., V.6. and V.7. is unlimited.
- 16. Participants are also entitled to use the additional services "Legacy PHP versions handling", "Legacy database servers handling", "Legacy Node.js versions handling", "2FA protection for e-mail", "CDN netart.com", "Convert to WebP and resize images", and "LSCache Plugins Support", up to the maximum duration of the promotional Subscription Period of the Hosting Service.
- 17. Within the first Subscription Period of 30 days, Participants are also entitled to use the additional service Data Backup 100 GB at a promotional price of 0 HUF, provided that they do not simultaneously order or have in the Client Panel the Data Backup service. The promotional prices indicated, unless otherwise indicated, are the lowest for the offer that was in effect during the 30-day period prior to the discount.
- 18. The number of services available in the promotion described in section V.17. is limited to one item.
- 19. The renewal of the Subscription Period of the service ordered in the promotion is made under the terms and conditions in effect at the time of renewal.
- 20. In the event of non-payment of the proforma invoice referred to in section IX.1. of the General Terms and Conditions, the effect of the termination of the Subscription Period of the Data Backup 100 GB Service is the immediate deletion of the data stored in the Data Backup 100 GB Service without the possibility of its restoration.
- 21. The use of the service ordered during the promotion period is subject to the general rules for the use of services, contained in the General Terms and Conditions and the Regulations of the Hosting Service and the Additional Service.

## VI. Other provisions

- 1. The relationship between netart.com and the Client is governed exclusively by the provisions of the substantive law of the Republic of Poland. The above provision shall not limit the rights acquired under the law by a Consumer residing in the territory of the European Union.
- 2. Any disputes that may arise from the agreement between the Client and netart.com, which cannot be resolved using the complaint procedure, will be settled by a common court of law with jurisdiction over the seat of netart.com. The place of provision of the service is the registered office of netart.com.
- 3. The language applicable to the conduct and settlement of disputes referred to in Section VI.2 above and settled by Polish courts, shall be Polish.
- 4. For matters not regulated in these Regulations, the provisions of the General Terms and Conditions available at <https://www.netart.com> shall apply.
