n) .no domain for the first Subscription Period of one year, at a promotional price of 1 500.00 ISK net (the lowest price for this offer from the period of 30 days prior to the application of the price reduction – 500.00 ISK net),

 o) .pl domain for the first Subscription Period of one year, at a promotional price of 1 500.00 ISK net (the lowest price for this offer from the period of 30 days prior to the application of the price reduction – 250.00 ISK net),

or

 p) .pt domain for the first Subscription Period of one year, at a promotional price of 2 500.00 ISK net (the lowest price for this offer from the period of 30 days prior to the application of the price reduction – 1 000.00 ISK net),

or

 ro domain for the first Subscription Period of one year, at a promotional price of 1 500.00 ISK net (the lowest price for this offer from the period of 30 days prior to the application of the price reduction – 750.00 ISK net),

or

- r) .se domain for the first Subscription Period of one year, at a promotional price of 2 500.00 ISK net (the lowest price for this offer from the period of 30 days prior to the application of the price reduction – 1 500.00 ISK net).
- 9. The number of services available under the promotion described in Section V.8. is unlimited. When ordering a service, the Customer is obliged to pay the entire price in advance, for all Subscription Periods.
- 10. The place of provision of the service is the registered office of netart.com.
- 3. The language applicable to the conduct and settlement of disputes referred to in Section VI.2 above and settled by Polish courts, shall be Polish.
- 4. For matters not regulated in these Regulations, the provisions of the General Terms and Conditions available at https://www.netart.com shall apply.
