

# Regulations of the promotion "nTLD domains at netart.com"

### I. Preliminary Provisions

- 1. **Promotional purpose:** Familiarizing the Customer with the domain registration service provided by netart.com Sp. z o.o. with its registered office in Krakow, ul. Pana Tadeusza 2, 30-727 Krakow, registered in the Register of Entrepreneurs kept by the District Court for Krakow Śródmieście in Krakow, XI Commercial Division of the National Court Register under KRS no.: 0001000590, with a share capital of PLN 1,000,000.00 (in words: one million zloty), REGON no.: 523601938, NIP no.: 6793252454, email address: contact@netart.com hereinafter referred to as netart.com.
- Duties (obligations) of the parties: netart.com undertakes to provide services according to the terms set
  out in these Regulations, and the Client undertakes to use the service according to these Regulations, the
  GTC, the Regulations for the provision of domain registration service and related services, and other
  provisions referred to in the said documents.

# II. Organiser of the promotion

1. The organizer of the promotional action "nTLD at netart.com" is netart.com.

## III. Legal regulation of the promotion

- 1. The legal basis for the promotion is provided by these Regulations, which is also the only document setting out the detailed rules of the promotion. The content of the Regulations is available at https://www.netart.com.
- Participation in the promotion is voluntary.
- 3. The interpretation of the Regulations rests solely with the organiser of the promotional campaign. This provision shall not apply to a Consumer residing in the territory of the European Union.
- 4. - 6. In addition, the Client is entitled to order domains specified in section V.5, for a Subscription Period longer than that specified in section V.5, provided that such service is available. The order price is the result of adding together the promotional price for the first Subscription Period and the standard price for each additional Subscription Period, as specified in the price list available at https://www.netart.com.
- The number of services described in V.5 and V.6 is unlimited. When ordering a service, the Client is obliged
  to pay the total price in advance for all Subscription Periods.
- 8. In the case of each transfer of a domain, registered in the promotion described in section V.5., to another service provider before the expiration of the period for which the service was ordered in the promotion, the Client will be obliged to pay to netart.com a contractual penalty in the amount corresponding to the standard price (specified in the price list available at https://www.netart.com), for the period from the day following the day of transferring the domain to another service provider to the day on which the last Subscription Period of the service ordered in the promotion would have ended.
- 9. The transfer of a domain registered under this promotion to another Customer Panel is possible as long as the Customer to whom the domain is transferred can take advantage of this promotion.
- 10. The net prices specified above will be increased by the applicable VAT, at the rate in force in the country where the service is taxed in accordance with the applicable legislation.
- 11. The selection of the domain in the promotion is made during the order process.
- 12. The renewal of the Subscription Period of the service ordered in the promotion is made under the terms and conditions in effect at the time of renewal.
- 13. The use of the service ordered during the promotion period is subject to the general rules for the use of services, contained in the General Terms and Conditions and the Regulations of the domain registration service and related services.

### VI. Other provisions

- 1. The relationship between netart.com and the Client or the Registrant is governed exclusively by the provisions of the substantive law of the Republic of Poland. The above provision shall not limit the rights acquired under the law by a Consumer residing in the territory of the European Union.
- Any disputes that may arise from the agreement between the Client or the Registrant and netart.com, which
  cannot be resolved using the complaint procedure, will be settled by a common court of law with jurisdiction
  over the seat of netart.com. The place of provision of the service is the registered office of netart.com.
- The language applicable to the conduct and settlement of disputes referred to in Section VI.2 above settled by Polish courts, shall be Polish.
- 4. For matters not regulated in these Regulations, the provisions of the General Terms and Conditions available at https://www.netart.com shall apply.
